

Dr. Yetty Komalasari Dewi, SH., MLI



Yetty Komalasari adalah dosen tetap pada bidang Hukum Ekonomi dan Teknologi di Fakultas Hukum Universitas Indonesia.

Biografi

Yetty Komalasari Dewi bergabung sebagai asisten dosen pada mata kuliah Hukum Dagang di Fakultas Hukum Universitas Indonesia sejak tahun 2000. Saat ini, Yetty adalah Ketua Bidang Studi/Departemen Hukum Ekonomi dan Teknologi, dan Ketua *Legal Center for International Trade and Investment (LCITI)* FHUI. Sebelumnya Yetty telah bertanggung jawab sebagai Ketua Unit Penjaminan Mutu Akademik (2018-2019), Ketua Sub Program Kelas Khusus Internasional (2016-2017), Ketua Sub Program Doktor (2014-2016), dan Kepala Sekretariat Pimpinan merangkap Sekretaris Fakultas (2006-2008). Yetty juga pernah menjadi Sekretaris Eksekutif dari Pusat Kajian Anti Pencucian Uang (PUKAU), suatu lembaga riset yang didirikan oleh Fakultas Hukum UI, Pusat Pelaporan dan Analisa Transaksi Keuangan, dan Bank Indonesia (2011-2014). Selain aktif mengajar, Yety aktif pula melakukan berbagai penelitian baik penelitian yang dididkannya melalui berbagai hibah (*grant*) maupun secara mandiri. Fokus penelitian Yetty adalah isu-isu hukum perusahaan, hukum perdagangan, hukum investasi dan arbitrase baik nasional maupun internasional.

Pada tingkat nasional, saat ini Yetty melakukan fungsi pengabdian masyarakatnya sebagai Asisten Staf Khusus Bidang Hukum Wakil Presiden RI (2011-sekarang). Pada tingkat regional, sejak 2016 Yetty menjadi perwakilan Indonesia sebagai *Subject Editor, Asian Journal of Comparative Law (AsJCL)*, *National University of Singapore (NUS)*, Singapura. Selain itu, Yetty juga menjadi *Rapporteur* pada *Break-out Sessions: Regional Investment Policy Processes and Their Contribution to Phases 1 and 2 of Sustainable Development-oriented IIA Reform: Developing countries: Asia, The 2019 edition of UNCTAD's Annual High-level IIA Conference*, pada November 2019 di Jenewa, Swiss.

Yetty juga turut aktif memberikan sumbangan pemikiran kepada berbagai lembaga/kementerian dan masyarakat baik sebagai narasumber, tenaga ahli maupun ketua dalam penyusunan berbagai produk peraturan perundang-undangan sesuai dengan bidang keahliannya, antara lain LPOM-MUI, Ombudsman RI, BPHN, BI, BKPM, LPS, DPD RI, KPK, BKPM, Kementerian Luar Negeri, Kementerian Perindustrian, Kementerian Perdagangan, Kementerian Hukum dan HAM, Kepolisian RI dan sebagainya.

Yetty is an associate professor and a full time lecturer at Faculty of Law, Universitas Indonesia. Yetty earned her Bachelor degree (Sarjana Hukum/SH) from Faculty of Law, Universitas Indonesia (UI) in 1993, her Master of Legal Institution (MLI) from School of Law, University of Wisconsin-Madison, the USA in 2003, and her Doctorate degree in Law (Dr) from UI in 2011. Her research interest is (international) trade/commercial/business law, company/corporate law, investment law, and arbitration. Currently, she is the Head of the Department of Law in Economic Activities and Technology as well as the Head of the Legal Center for International Trade and Investment (LCITI), Faculty of Law, Universitas Indonesia.

Yetty is in charge for numbers of courses, namely Trade/Commercial Law, Corporate/Company Law, Investment Law, Arbitration (Commercial/Investment) and International Trade Law (WTO Law), both in undergraduate and graduate programs. Yetty plays an active role in research institutions, and currently serving as a member of Reviewer Board of Indonesian Law Review (ILRev) of the same university, a member of subject editors of the Asian Journal of Comparative Law (AsJCL), the National University of Singapore, and a certified international research reviewer (CIRR). She is also an assessor for National Accreditation Body (BAN-PT), the Ministry of Higher Education and for the ASEAN University Network - Quality Assurance (AUN-QA). Yetty is also a member of the Indonesian Association of Economic Law Lecturers (PDHEI, Deputy Secretary); the Society of International Economic Law (SIEL); and The Asia WTO Research Network (AWRN).
